

Pennsylvania Bipartisan Safer Communities Act Stronger Connections Grant Program Fact Sheet

What is the Stronger Connections Grant?

As part of the Bipartisan Safer Communities Act (BSCA), this grant provides <u>\$1 billion in funding</u> to State educational agencies (SEAs) to be distributed under Title IV, Part A of the Elementary and Secondary Education Act of 1965 (ESEA). The BSCA specifies that SEAs must make competitive subgrants to high-need

local educational agencies (LEAs), as determined by the SEA, for activities to support safe and healthy students under section 4108 of the ESEA. Under section 4108, schools/districts can implement activities and programming that help establish safer and healthier learning environments, and prevent and respond to acts of bullying, violence, and hate that impact school communities at individual and systemic levels, among other programs and activities.



Pennsylvania PROGRAM

The state of <u>Pennsylvania</u> will award \$39,000,000 in Stronger Connections Grant funds. For the purposes of this grant, Pennsylvania has defined a <u>high-need local education agency</u> as a school entity that:

- 1. Is a school district or charter school in Pennsylvania;
- 2. Received ESEA Title IV, Part A funding in fiscal year 2022; and
- 3. Meets one or more of the following "high-need" criteria:
 - A high rate of poverty;
 - A lack of mental health supports available to students;
 - High rates of violence and/or traumatic incidents in the school or community; and
 - High rates of school exclusion.

Applications must be completed and submitted through the PDE <u>eGrants</u> online grants management system. **Applications are by invitation only.**

Eligible Uses:

Eligible uses will largely fall into these categories:

- Promoting the social, emotional, physical, and mental well-being of students and staff
- Addressing family and community engagement
- Promoting equitable and inclusive policies and practices in the LEA



What can Pennsylvania schools purchase with grant funds?

For the most part, allowable expenses have been detailed under <u>Section 4108</u> of the Elementary and Secondary Education Act (ESEA). On the following page are some of the supported programs and activities, along with examples of tools that Pennsylvania schools can use to execute these programs and activities.

Activity/Program	Securly Solution
